The **Deadline of Submission/ Opening of Bidding Documents will be on 07 September 2023, 1:00pm** at CBB Conference Room, 2nd Floor Central Block Building, JRRMMC, Rizal Ave., Sta. Cruz, Manila.

All particulars relative to the eligibility, bid evaluation, and award of contract shall be governed by the provisions of R.A. 9184 otherwise known as the Government Procurement Reform Act. Bids received in excess of the Approved Budget of the Contract (ABC) shall be automatically rejected at bid opening. **LATE BIDS SHALL NOT BE ACCEPTED. ALTERNATIVE BIDS SHALL BE REJECTED.**

Bid Security shall be in the acceptable form and in the amount stated in the Philippine Bidding Documents.


