Bids received in excess of the Approved Budget of the Contract (ABC) shall be automatically rejected at bid opening. **LATE BIDS SHALL NOT BE ACCEPTED. ALTERNATIVE BIDS SHALL BE REJECTED.**


Bid Security shall be in the acceptable form and in the amount stated in the Philippine Bidding Documents.
