The pre-bidding conference will be on 21 November 2023, 9:00am at the AVR, 5th Floor, Main Building, JRRMMC, Rizal Ave., Sta. Cruz, Manila. The Submission/Opening of Bidding Documents will be on 5 December 2023, 8:30am, at the AVR, 5th Floor, Main Building, JRRMMC, Rizal Ave., Sta. Cruz, Manila

All particulars relative to the eligibility, bid evaluation, and award of contract shall be governed by the provisions of R.A. 9184 otherwise known as the Government Procurement Reform Act. Bids received in excess of the Approved Budget of the Contract (ABC) shall be automatically rejected at bid opening. LATE BIDS SHALL NOT BE ACCEPTED. ALTERNATIVE BIDS SHALL BE REJECTED.

Bid Security shall be in the acceptable form and in the amount stated in the Philippine Bidding Documents.
