It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids. The pre-bidding conference will be on 25 February 2025, 1:30pm at the CBB Conference Room, 2nd Floor, CB Building, JRRMMC, Rizal Ave., Sta. Cruz, Manila.

The Submission/ Opening of Bidding Documents will be on 11 March 2025, 9:00am, at the CBB Conference Room, 2nd Floor, CB Building, JRRMMC, Rizal Ave., Sta. Cruz, Manila

All particulars relative to the eligibility, bid evaluation, and award of contract shall be governed by the provisions of R.A. 9184 otherwise known as the Government Procurement Reform Act. Bids received in excess of the Approved Budget of the Contract (ABC) shall be automatically rejected at bid opening. LATE BIDS SHALL NOT BE ACCEPTED. ALTERNATIVE BIDS SHALL BE REJECTED.

Bid Security shall be in the acceptable form and in the amount stated in the Philippine Bidding Documents.
