
ALL BIDS MUST BE SUBMITTED WITH THE FOLLOWING:

1. Bid Security in the form of Cash or Manager's Check equivalent to ten percent (10%) of the total Bid Price;
2. Legal/Technical documents along with its bid tender in a sealed brown envelope:
 - a. SEC Registration or DTI Certificate of Registration
 - b. Mayor's Permit/Business Licenses
3. Duly signed Instruction to Bidders and Terms & Condition of Sale; and
4. Bidders Inspection Certificate.

The Opening of sealed bid forms will be held on **May 15, 2024** at exactly **10:00 AM** at the **CBB Conference Room 2nd Floor, Rizal Ave., Sta. Cruz, Manila**. The minimum bid shall not be lower than the government floor price.

This Invitation to Bid for the Sale of Property will be posted in at least three (3) public places in the locality, and in the Official JRRMMC Website (jrrmmc.gov.ph).

The JRRMMC reserves the right to reject any or all of the bids with or without cause, to annul the auction process, to waive any defect in them and to award the bidder whose bid is the most advantageous to the government.
