Bids received in excess of the Approved Budget of the Contract (ABC) shall be automatically rejected at bid opening. LATE BIDS SHALL NOT BE ACCEPTED. ALTERNATIVE BIDS SHALL BE REJECTED.

Bid Security shall be in any of the acceptable forms and in the amount stated in the Philippine Bidding Documents.
