ADDENDUM NO. MS-N95-01 s. 2021

This Addendum No. MS-N95-01 s. 2021 is issued to clarify or amend items in the Bid Documents. The following were the changes in the Description to be bid made during the pre-bid conference for the procurement of Particulate Mask held last 22 November 2021. This shall form an integral part of the Bid Documents.

- ❖ PhilGEPS Certificate must be Platinum and valid during the opening of bids
- ❖ Must attach the "Class A Documents".
- ❖ Conditions set forth at the Mayor's permit should be **COMPLIED** by the company with attached proof of compliance.
- ❖ Tax Clearance must be updated during opening of bids
- ❖ Audited Financial Statement must have stamped "**RECEIVED**" by the BIR or **its duly accredited and authorized institutions (Electronically submitted AFS is acceptable as long as with acknowledgment receipt by the BIR)**
- ❖ Bidders shall submit Audited Financial Statement for the year 2019 & 2020.
- ❖ Bid Security must be addressed to **JOSE R. REYES MEMORIAL MEDICAL CENTER**
- ❖ Proper filling in the form of Good offered from Abroad / within the Philippines
 - **SECTION 32.2.1 of R.A 9184 Revised Implementing Rules and Regulation**

Completeness of the Bid. Unless the Instructions to Bidders specifically allow partial bids, bids not addressing or providing all of the required times in the Bidding Documents including, where applicable, bill of quantities, shall be considered as non-responsive, but specifying a "0" (ZERO) for the said item would mean that it is being offered for free to the Government

- ❖ Observe proper tabbing for the Bid Documents
- ❖ Certified True Copy Stamp may be in any color of ink but the signature must be **RED INK**.
- ❖ Folders and Envelopes must be colored **YELLOW**.
- ❖ Statements of Single Largest Completed Contract and Statement of On-Going private and government contracts are no longer needed to be notarized and no attachments required.
 - Bidders may submit at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least 25 % the percentage of the total ABC to be bid.
- ❖ **Brochure** Must be attached on the bidding documents that will be submitted by the bidders.
- ❖ At least two (2) Certificate for Good Performance from government or private hospitals **or LGU provided that the items are hospital supplies within the past two (2) years is needed**
- ❖ **SUBMISSION OF SAMPLES**
 - Lowest bidder shall submit at least **five (5) samples** within five (5) calendar days after the receipt of abstract of bids
 - Ensure proper labelling of samples: **Company/ Category/ Item no.**
 - Samples will be subjected to post-qualification evaluation of the TWG as to quality and compliance with the specifications
- ❖ **CERTIFICATE OF PRODUCT REGISTRATION - Must be attached to the "Technical Specifications" (if applicable)**
 - If CPR is for renewal. No application for renewal shall be accepted **unless** the prescribed renewal fee is paid. There shall be automatic renewal of the CPR when the following conditions are satisfied:
 - The application is filed before the expiration date of the registration
 - The prescribed renewal fee is paid upon filing of the application: and
 - A sworn statement indicating no change or variation whatsoever in the product is attached to the application.
 - Initial application for CPR is **not** acceptable
- ❖ Bidders shall attach the filled up Checklist of Requirements in their Eligibility Envelope per category.
- ❖ Each Bidder shall submit one (1) Mother Envelope containing two (2) envelopes. The first envelope shall contain one (1) original and two (2) photocopies of legal, technical and financial eligibility documents. The second envelope shall contain one (1) original and two (2) photocopies of financial components and the soft copy (PDF copy may be in CD or flash drive) of both legal, technical and financial eligibility documents and financial components.

- ❖ **PRICE VALIDITY - For the given scope of work in this Contract as awarded, all bid prices are considered fixed prices, and therefore not subject to price escalation during contract implementation in accordance with Section 61 of R.A. 9184 and its IRR**

- ❖ **DELIVERY SCHEME - Staggered Delivery and will be based on the needs of the patients**
- ❖ **Domestic Preference**
 1. A Domestic Bidder can only claim preference after it has secured from the Competitiveness Bureau of the Department of Trade and Industry, a certification that the articles forming part of its bid are substantially composed of articles, materials or supplies grown, produced or manufactured in the Philippines. The Certification shall form part of the Financial Envelope of the bidder claiming preference.
 2. When the LCB including taxes and customs duties, is a "foreign bid" as defines in C.A. No. 138, the award shall be made to the bidder who submitted the lowest "domestic bid", provided that:
 - a) The domestic bid is not more than **fifteen per centum (15%)** in excess of LCB. **(Section 3 [e] C.A. No. 138);**
 - b) The bidder who submitted the lowest domestic bid must pass the post-qualification; and
 - c) The award to domestic bidder shall be at the amount of the lowest "foreign bid"
