A. Logistics

1. Weekly Monitoring and Inventory of PPE
2. Provision of Meals for Frontliners
3. Reporting to different agencies
 - a. Weekly Consumption to DOH Portal
 - b. Monthly Consumption report to CMPS
 - c. Monthly Accomplishment report to MCC

B. Operations

1. Monitoring and reporting of daily patient census
2. Facilitation of swab procedures and outsourcing to different testing facilities
3. Facilitation of routine employee testing thru Philippine National Red Cross
4. Releasing of swab test results

C. Safety

1. Conduct facility risk assessment for patients, staff and employee to ensure proper containment.
2. Identify breach and risk practices in handling patients
3. Coordinate with IPCC the necessary learning reinforcement in ensuring safety practices that can enhance management based from risk assessment.
4. Surveillance and counsel of active confirmed healthcare workers. Directs COVID positive employees and family on proper quarantine and isolation management.
5. Monitor status of COVID positive and exposed employees towards development of complications.
6. Coordinate with Employee Service Consultant and Department of Family Medicine on the evaluation of COVID positive and exposed based from contact tracing.
7. Review and recommend guidelines/policies on prevention of transmission of COVID-19.
