**Background:**

Due to Covid-19 surge NCR was placed under Enhance Community Quarantine (ECQ) status during the 1<sup>st</sup> week of September which was shifted to a week Modified Enhanced Community Quarantine (MECQ) with heightened restriction as there are still increase in the number of Covid19 cases and variants of concern. For the last 2 weeks of the month NCR was placed under alert level 4, which is a new classification of quarantine alert system. Hence, to contain the transmission of the disease we still have to observe practice of minimum health standard protocol so as with limitation of face-to-face communication though with 4 day duty/week. The Public Health, Emerging Disease and Wellness Unit humbly submits the following accomplishment:
