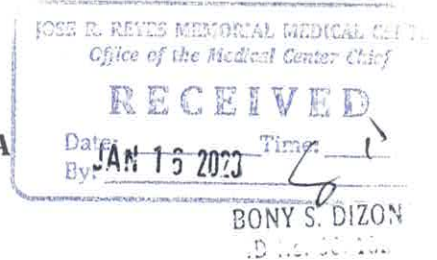

### I. Disaster Preparedness Activities

#### A. Capacity Building
