Background:

NCR's quarantine status on the 1st week of August was General Community Quarantine (GCQ) with heightened restriction. It was followed by 2 weeks of general Community Quarantine (GCQ) as there was huge increase in the number of Covid19 cases and variants of concern which in later part of the month was shifted to Modified Community Quarantine (MECQ). With increasing number of Covid -19 cases, our hospital continuously observes limitations in the activities brought about by the high risks of transmissibility of the COVID-19 virus which includes mutation and detection of the highly transmissible delta variant . Hence, still with limitation in the delivery of health and limitations of face-to-face communication though with 4 day duty/week the Public Health, Emerging Disease and Wellness Unit humbly submits the following accomplishment:
